## ND 40% Income Tax Credit

An added benefit for those who receive income from North Dakota, either from earnings, corporate income, or trusts:

Individuals that donate a minimum of \$5,000 and businesses that donate any amount in one calendar year to the **Richardton Area Community Foundation** qualify for a ND 40% State Income Tax Credit on their gift (credit limits apply—check with your tax advisor).

The table below shows the actual cost of a gift to a ND qualified endowment fund for donors in the 33% tax bracket.

Gift Amount:	\$5,000	\$25,000	\$50,000
Federal tax savings	(\$1,600)	(\$8,000)	(\$16,000)
ND state income tax credit	(\$2,000)	(\$10,000)	(\$20,000)
<b>Net cost of gift</b>	<b>\$1,400</b>	<b>\$7,000</b>	<b>\$14,000</b>
