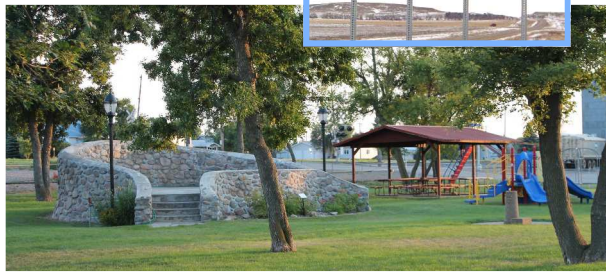

Who We Are

Established in 2013 through a generous gift from the former New Salem Credit Union, the **New Salem Area Community Foundation** is a permanent endowment fund that can support our community for years to come. Earnings from the fund are given as grants to support nonprofit projects or programs in the area that work to improve our community and quality of life.

The North Dakota Community Foundation, a nonprofit, tax-exempt corporation under IRS code 501(c)(3) and North Dakota Law, provides professional management of the fund. Gifts to the fund are tax-deductible to the fullest extent of state and federal law.



How to Get Grants

Grants from the endowment fund's earnings will be awarded each year. Application forms and information about the process are available online at www.NDCF.net/NewSalem. The **New Salem Area Community Foundation** Advisory Committee will discuss applications and determine grant awards.
