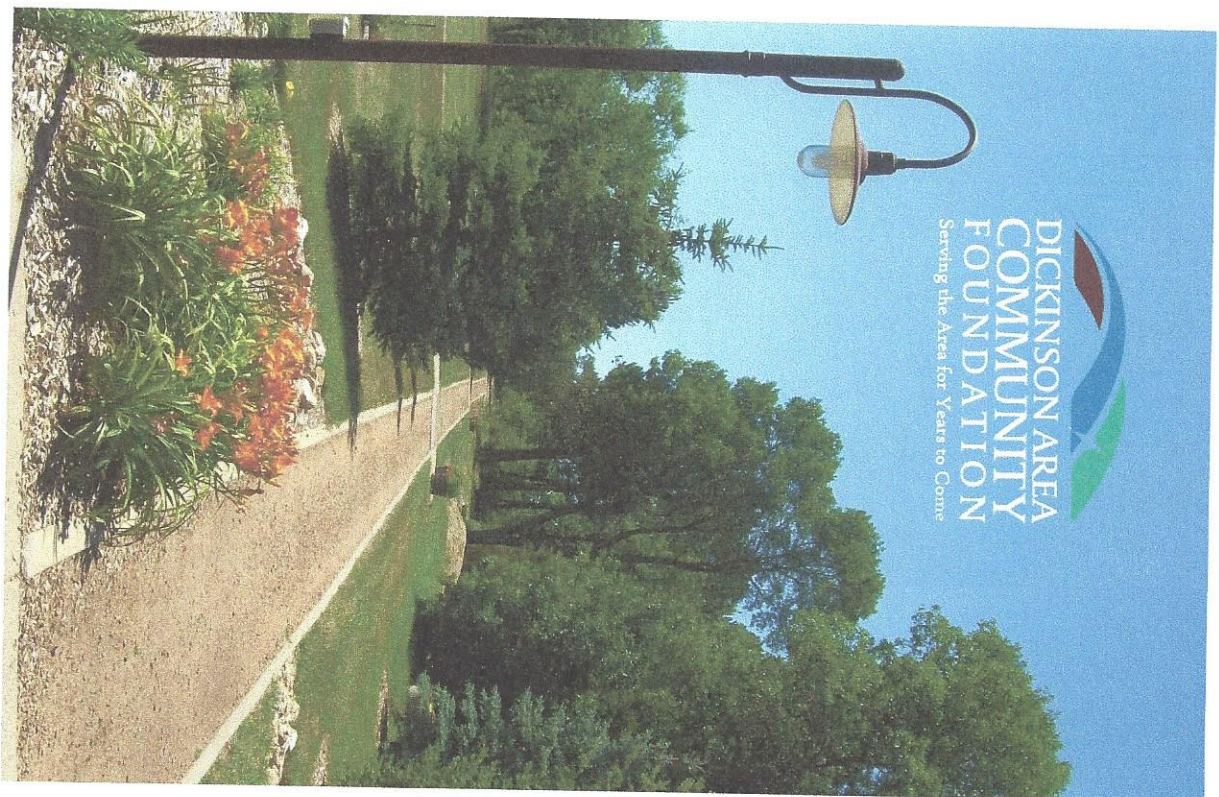

### Our Partnership

The Dickinson Area Community Foundation (DACF) is a component fund under the umbrella of the North Dakota Community Foundation (NDCF). Established in 1976, NDCF manages over 600 charitable funds, including 62 local community foundations, and over \$70 million for the betterment of North Dakota citizens and their communities. NDCF has extensive experience in facilitating asset transfers to funds, setting up charitable trusts and gift annuities, and ensuring Legacy gifts such as bequests are safely and accurately used in the community for which they are destined.
