\$17,000 Awarded in 2020

This year, the Richardton ACF Advisory Committee awarded a total of \$17,000 in 5 different grants to the following organizations and projects:

- PAWS (Richardton-Taylor School District): \$6,000 for the Richardton-Taylor Public School Playground
- Richardton Health Center, Inc.: \$5,000 for server installation/technology upgrade for more efficiency, increased security, and improved care for residents
- American Legion Post 180: \$2,000 for American Legion Memorial repairs
- Richardton Senior Citizens Center: \$2,000 to update lighting and other gas/ electrical updates
- Richardton-Taylor School: \$2,000 to defray costs for kids to attend the National Speech and Debate Tournament

Grants are awarded once a year. Any organization with a 501(c)(3) status or government agency may apply. Applications are available online at www.NDCF.net/Richardton.

Planned Giving Options

Along with our annual giving campaign, there are also opportunities to make other types of gifts, including planned gifts to the Richardton Area Community Foundation (RACF) that may be of interest to our residents:

- IRA Charitable Rollover Individuals that are 70 1/2 or older may make gifts of up to \$100,000 directly from their IRA to the North Dakota Community Foundation, benefiting the RACF. You can avoid taxes on the amount you transfer and satisfy your required minimum distribution (RMD), if you are over 72.
- Charitable Gift Annuity (CGA) A Charitable Gift Annuity is a contract between a charity and an individual. The individual, referred to as the donor, transfers property to the NDCF for the RACF and NDCF promises to pay a given amount at the end of each selected payment period to one annuitant for life or two annuitants for both lives (usually the donor or the donor and his/her spouse). The remaining principle is put in the RACF when they pass.
- Charitable Remainder Uni-Trust The Charitable Remainder Unitrust is a special trust that pays income to family members. After all of the income payments have been completed, the remainder is distributed to qualified charities, in this case the NDCF for the RACF. The person who establishes the trust may select the unitrust percentage, the persons to receive the income from the trust, and the charities which will receive the principal of the trust after all income payments are completed. You could choose several charities, in addition to the RACF.
- Bequest A bequest is property or money that you promise in your will to give to another person or organization after you die. If you would like to leave some or all of your estate to the RACF, the bequest language is as follows:

"I give and bequeath to the North Dakota Community Foundation (Tax ID 45-0336015), a qualified charitable organization under IRS 501 (c)(3), located in Bismarck, North Dakota, ____(a percentage of the estate, specific dollar amount, or remainder of estate) to the Richardton Area Community Foundation, a
