### Food Pantry Receives 2023 Grant

The Killdeer Area Community Foundation Advisory Committee awarded their entire 2023 grantable balance of \$4,280 to the Dunn County Food Pantry to provide meat options to those most in need in the area.

The food pantry has two locations: one in Killdeer and one in Halliday. They are open two days a month for four hours.

*"We serve anyone that comes into our pantries that need food assistance,"* said board member Annie Nies in their application. *"We give out approximately 6,000 pounds of food a month and serve an average of 75-100 people each day we are open."*

Grants are awarded from the fund once a year. Any organization with a 501(c)(3) status or government agency may apply. Applications are available online at [www.NDCF.net/Killdeer](http://www.NDCF.net/Killdeer).



## Real North Dakotans Making a Difference In Their Community

Making a lasting difference in your community or for future generations may be easier than you realize. With very simple language in your will or trust, you can support the Killdeer Area Community Foundation (KACF) and continue to provide resources for projects and programs well into the future.

If you have children or other relatives, you can leave a portion of your estate to them and a percentage to KACF. Doing so provides for your heirs while honoring your charitable values.

Other North Dakotans have left a legacy in their community:

- Tom Larson was the City Manager, Assessor, and Auditor for Park River, ND and a tremendous community leader. When he passed away at the age of 54, he left almost \$120,000 to the Park River Community Endowment Fund.



- T.A. and Anna Solheim left 50% of their estate to their heirs and certain percentages of their estate to various nonprofit organizations, including 15% to the Minot community.
- Brothers Russell and Dale Brown left gifts to the communities of Lisbon and Milnor in their estate plans.



If you would like to have a profound impact on future generations of Dunn County residents, you can contact NDCF for more info or just include the following text in your will:

"I give and bequeath to the North Dakota Community Foundation (Tax ID 45-0336015), a qualified charitable organization under IRS 501 (c)(3), located in Bismarck, North Dakota, \_\_\_\_\_ (a percentage of the estate, specific dollar amount, or remainder of estate) to the **Killdeer Area Community Foundation**, a permanent component of the North Dakota Community Foundation."
