Growing to Serve More

We encourage each social group, individual, business, etc. to make some sort of gift from time to time. Over the years, all those gifts will grow this permanent fund to be an even more valuable resource for our area.

We currently have approximately \$148,000 in assets in our community foundation. We would like to grow this amount to \$500,000 based on the needs in our community. This is a general purpose fund, which means the committee surveys needs annually, takes applications and awards grants based on the priority of that year. A larger fund will allow us to be of more help to critical projects that improve the quality of life in and around Hebron. Eventually, our service providers can focus on their mission instead of fundraising to provide their service. The chart below shows other community funds and the impact they have in their area.

| Fund | Asset Value | Approx. Annual Grants |

| Richardton | \$434,000 | \$15,000 |
| Ellendale | \$688,000 | \$24,500 |
| New Salem | \$1.3 million | \$53,000 |
