Our Endowment Fund

The Richland Wilkin Community Foundation permanent endowment fund was established in 1984 by a group of area business owners. Originally called the Breckenridge/Wahpeton Community Foundation, the name changed in 2016 to better represent the area it serves. Donations and gifts to this fund are invested and a portion of the earnings is granted out every year to projects and programs that improve the quality of life for Richland and Wilkin County residents. Funds distributed from the permanent fund are designed to be reinvested locally through nonprofit organizations in the region.

The Elmer & Lucille Hoffert Fund was established in 2004 and is a sub-fund of the RWCF's endowed fund. Although it is a separate fund, it's grantable balance every year is awarded with RWCF grants.



RWCF Annual Campaign Fund

The RWCF continues the important work of partnering with local employers to raise funds to meet the needs our local non-profit organizations. Building on the legacy of the former United Way, we continue to engage in an annual campaign that incorporates local employers and their employees who generously give through their company payroll. The RWCF in turn, will coordinate with the local non-profit network to distribute funds as effectively as possible. The local advisory committee is a cornerstone of the RWCF and is able to make decisions to best fit the ever-changing needs our communities.

In 2023, RWCF again partnered with Titan Machinery in hosting an 18-hole golf scramble at the Bois De Sioux Golf Course. Golfers enjoyed beautiful weather while swinging their way to prizes and awards. Many corporate sponsors also contributed to make this a fun and successful event. Plans are already being made for the 2024 event - we hope you can join us!

The Agricultural Partnership program that was started in 2022, continues to be a resource for area farmers to be able to support our nonprofit community by gifting a portion of their harvest. By coordinating with the local elevators and tax professionals, RWCF is able to accept gifts of agricultural commodities, which has significant tax benefits to our producers.

Through all these fundraising efforts, RWCF's Annual Campaign Fund was able to grant over \$53,000 to local nonprofits!

RWCF Power of 100

The Richland Wilkin Power of 100 is a form of social giving. The community gathers for an event where three charities share their story. Participants are asked to donate \$100 or more per event. After enjoying food, beverages and



entertainment, attendees vote for their favorite nonprofit. A portion of the money raised is invested in the RWCF endowment fund to generate future grant dollars for area nonprofits. The remaining money is divided up between the charities in attendance that night.

Although the fundraising piece for these nonprofit organizations is important, it's not the main reason for the events. What is more crucial: exposing area residents to the many different nonprofit organizations that are serving people in Richland and Wilkin County and explaining the role of the Richland Wilkin Community Foundation in addressing the varied needs of the area.

Making a lasting difference in our communities or for future generations may be easier than you realize. With very simple language in your will or trust, you can help the Richland Wilkin Community Foundation (RWCF) continue to support important projects and programs in our area forever.

Gifts to the RWCF endowment fund are carefully invested by our partner foundation - the North Dakota Community Foundation - to generate a permanent source of charitable income.

If you have children or other relatives, you can leave a portion of your estate to them and a percentage to RWCF. Doing so provides for your heirs while honoring your charitable values.

"Thanks to the ongoing support of the **Richland Wilkin Community Foundation**, Kinship has been able to place mentors in the lives of 564 youth like Rylan. Rylan's mom felt it would be great for him to have support and positive role modeling because they don't have a strong local support system. Rylan has gained selfesteem, social-emotional skills, and overall improvement of making safer, healthier, and wiser choices through the positive feedback, encouragement, learning opportunities, connections and experiences his mentor and Kinship provide. His mom stated, "I couldn't even say enough good things...The whole experience has been an eye opener. [Jim] always wonders how he can come alongside us in any way. He started out as a mentor, but he is family to us now."

Kinship is the ONLY youth mentoring

organization serving our community; without it, 134 current youth, many experiencing a multitude of ACEs (Averse Childhood Experiences), would be lacking mentor support. Most of our kids lack a strong natural support system & healthy outlet to help navigate life's tribulations. Kinship's mission is to improve lives by establishing quality relationships between youth and caring mentors for the purpose of promoting stability, support, friendship, & community.
