Our Partnership

The Dickinson Area Community Foundation (DACF) is a component fund under the umbrella of the North Dakota Community Foundation (NDCF). Established in 1976, NDCF manages over 650 charitable funds and over \$80 million for the betterment of North Dakota citizens and their communities. NDCF provides comprehensive charitable services including donor gift planning, bequest planning, and fiduciary services such as accounting, audit, and money management.

In addition to awarding grants from the DACF Endowment Fund, we also help facilitate special projects within our community. For example, the DACF has helped the Friendship Park Committee raise nearly \$200,000 to build an inclusive playground. The DACF also helps facilitate Donor Advised Funds like the Little Buddy Foundation which benefits children with prosthetics.
