


# 2022 Annual Report



## Dear Friends

2022 was a memorable year for the Richland Wilkin Community Foundation. Activities, new and renewed, helped us reach our mission of "making this a better place to work, live, and raise our families". In addition, we increased philanthropy throughout the region.

Early in the year we launched our new Power of 100 program. The community responded with open arms to the challenge we set forth, to raise much needed funds for our area non profit organizations. We held three events through the year which included creative food, enticing entertainment, and wonderful recognition of the work we are doing in the two-counties. Each event showcased 3 area charities who were able to share their story and ask for the support of the attendees. For 2022, we hosted 9 non-profits, educated and further developed relationships with 300+ donors, and had a lot of fun along the way.





Also in 2022, we hosted our first annual golf tournament. This event was in partnership with Titan Machinery and exposed our agri-community to the work of the foundation and raised some funds to support this work.

These two initiatives, along with our previous donor development activities have allowed us to fund 26 grants to Richland-Wilkin charities. Together, we can do more! And together, we can continue this work well into the future!

## **Our Endowment Fund**

The Richland Wilkin Community Foundation permanent endowment fund was established in 1984 by a group of area business owners. Originally called the Breckenridge/Wahpeton Community Foundation, the name changed in 2016 to better represent the area it serves. Donations and gifts to this fund are invested and a portion of the earnings is granted out every year to projects and programs that improve the quality of life for Richland and Wilkin County residents. Funds distributed from the permanent fund are designed to be reinvested locally through nonprofit organizations in the region.

The Elmer & Lucille Hoffert Fund was established in 2004 and is a sub-fund of the RWCF's endowed fund. Although it is a separate fund, it's grantable balance every year is awarded with RWCF grants.



### **RWCF Annual Campaign Fund**

The Richland Wilkin Community Foundation took on additional focus and work in 2019 as the Richland Wilkin United Way closed its doors. Their funds were gifted to the RWCF to continue their work in the community. This was done with much thought and planning as the community continues to see a shift in annual giving.

Employee work-place giving has seen a change since the pandemic, yet the needs of the community have increased. The RWCF is working with area businesses to align with their processes, employees wishes, and needs of the workplace.

Annual campaign activities have included meeting with area businesses and their employees, along with increasing the awareness of the work we do in the region. An annual golf tournament was started in partnership with Titan Machinery in 2022 to included our agri-community and reach beyond the city limits. In addition, we have updated our website, social media, and options for on-line donations all to make giving more efficient.

In 2022, we implemented an Agricultural Partnership program where our farmers can make a charitable gift through their crops. Donations made through their local elevator have significant tax benefits and help our

RWCF continue the important work in our twin-county area.

#### **RWCF Power of 100**

The Richland Wilkin Power of 100 is a form of social giving. The community gathers for an event where three charities share their story. Participants are asked to donate \$100 or more per event. After enjoying food, beverages and



entertainment, attendees vote for their favorite nonprofit. A portion of the money raised is invested in the RWCF endowment fund to generate future grant dollars for area nonprofits. The remaining money is divided up between the charities in attendance that night.

"When we held our first two events, half the money went to endowment and the other half went to the charity that had the most votes," explained RWCF Director Jana Berndt. "But we realized that all the charities were deserving and important in our area, so we started giving them all some of the money, with the one receiving the most votes getting the largest amount."

Although the fundraising piece for these nonprofit organizations is important, it's not the main reason for the events. What is more crucial: exposing area residents to the many different nonprofit organizations that are serving people in Richland and Wilkin County and explaining the role of the Richland Wilkin Community Foundation in addressing the varied needs of the area. In 2022, we have over 300 donors participate in the Power of 100.

Power of 100 events are continuing in 2023 with new nonprofit organizations participating, and each event in growing in numbers.

## **Giving Other Than Cash**

The Richland Wilkin Community Foundation can accept many different types of gifts other than cash. Depending on your situation, you may want to consider donating one of the following for their tax benefits or other reasons:

- Real estate, which allows the donor to deduct the current appraised value of the real estate and avoid capital gains taxes.
- Fully depreciated business property (farm equipment, etc.) You can't take a tax deduction, but there is no tax due on the transfer and the value of the property qualifies for the North Dakota 40% income tax credit if you live in North Dakota and the gift is given to the Richland Wilkin Community Foundation's endowment fund.
- Gifts of farm commodities, which don't give a tax deduction, however they don't have to be counted as income. You can still deduct the cost of production for whatever you donate. These gifts also may qualify for the 40% North Dakota income tax credit for gifts to qualified ND endowment funds. (Note: you must donate the commodity first to get these



- tax advantages, not sell it and donate the proceeds later.)
- Appreciated investment assets, valued on the date of transfer, are tax deductible and you can avoid paying capital gains tax. These gifts may also qualify for the ND income tax credit.
- Charitable IRA rollover counts as your required minimum distribution, but you don't need to claim the donated portion as federal income and the gift may qualify for the 40% ND income tax credit.
- Gifts of mineral acres outright, assignment of mineral royalty income, or make the North Dakota Community Foundation an income or remainder beneficiary of your family mineral trust (Be sure to designate that the Richland Wilkin Community Foundation at NDCF should benefit from your generosity!)

## Leave Your Legacy in Richland/Wilkin!

Making a lasting difference in our communities or for future generations may be easier than you realize. With very simple language in your will or trust, you can help the Richland Wilkin Community Foundation (RWCF) continue to support important projects and programs in our area forever.

Gifts to the RWCF endowment fund are carefully invested by our partner foundation - the North Dakota Community Foundation - to generate a permanent source of charitable income.

If you have children or other relatives, you can leave a portion of your estate to them and a percentage to RWCF. Doing so provides for your heirs while honoring your charitable values.

If you would like to include the Richland Wilkin Community Foundation in your will, here is some sample language to consider:
