What an impact Grid United has had on our We have awarded \$192,000 in grants in 2023 and the spring of 2024 to organizations in our county for a variety of projects and programs. Unfortunately, we received total requests of over \$559,000 during that same time so we had to make tough choices. There are obviously more needs in our area, but the Grid funding will run out in 2025.

\$64,000 Awarded in Grants

The Grant County Community Foundation (GCCF) awarded five grants in April of this year to the following organizations:

- **Elgin Fire Protection District:** \$17,000 for SCBA's and masks
- Kidz Clubhouse: \$16,859 for improvement projects
- **Elgin New Leipzig Public School District:** \$15,141 for a swimming pool update
- New Leipzig Fireman's Auxiliary: \$10,000 toward a Prairie Fire Truck update
- **Country Community Cupboard Inc.:** \$5,000 for the purchase of food to stock the pantry

Give Other Than or In Addition to Cash?

Why, yes you can! The Grant County Community Foundation can accept many different types of gifts. Depending on your situation, you may want to consider donating one of the following:

- Gifts of farm commodities: Avoid income recognition by having the elevator make a direct transfer to the Grant County Community Foundation Endowment.
- Real estate, which allows the donor to deduct the current appraised value of the real estate and avoid capital gains taxes.
- Depreciated business property (farm equipment, etc.) Avoids recapture tax.
- Appreciated investment assets, valued on the date of transfer, are tax deductible and you can avoid paying capital gains tax.
- Over 70 1/2? A charitable IRA rollover counts as your required minimum distribution, but you don't need to claim the donated portion as federal income. Must be sent to NDCF by direct transfer.
- Gifts of mineral acres outright, assignment of mineral royalty income, or make the Grant County Community Foundation an income or remainder beneficiary of your family mineral trust.

Don't Forget About the Tax Credit

The North Dakota Charitable Income Tax Credit allows individuals with ND earned income that donate \$5,000 or more and businesses that donate any amount to qualified endowment funds to receive up to a 40% state tax credit.

Depending on your tax bracket, this means a \$5,000 gift to GCCF may end up only costing about \$2,000 after taking advantage of the tax credit and other deductions! (see chart below)
