The Larimore Community Endowment Fund was created to be a resource to support local community initiatives which provide a higher quality of life in the Larimore area. The community also receives grant dollars every year from the Vernon & Lila Halvorson Endowment Fund and the Charles D. McCanna Fund.


Recently, the Foundation's Advisory Committee granted a total of \$25,836 from these three funds to the following organizations:

- Larimore Park Board: \$6,336 for the Recreation Facility Repair Project
- Radiant Little Lambs Daycare Center: \$5,000 for health and safety updates
- **Larimore Fire Protection District:** \$2,750 for truck repairs
- **Bellevue Cemetery Association:** \$2,500 for beautification, maintenance, and upkeep
- Larimore Public Schools: \$2,500 for school devices
- United Way of Grand Forks, East Grand Forks & Area: \$2,500 for renovation to the Larimore Food Pantry
- Edna Ralston Library: \$2,000 for Summer Reading, shelving and lighting, and general operating expenses
- Sox for Kids \$1,000 to support their Sox for Kids 2022
- Larimore Senior Citizens Club: \$750 for a heater for the pool room
- Larimore High School After Prom Party: \$500 for the LHS Junior Class After Prom Party

Give Other Than or In Addition to Cash?

Why, yes you can! The Larimore Community Endowment Fund can and has received many different types of gifts. Depending on your situation, you may want to consider donating one of the following for their tax benefits or other reasons:

- Real estate, which allows the donor to deduct the current appraised value of the real estate and avoid capital gains taxes.
- Fully depreciated business property (farm equipment, etc.) You can't take a tax deduction, but there is no tax due on the transfer and the value of the property qualifies for the ND 40% income tax credit if given to a qualified ND endowment fund, such as the Larimore Community Endowment Fund.
- Gifts of farm commodities, which don't give a tax deduction, however they don't have to be counted as income. You can still deduct the cost of production for whatever you donate. These gifts also may qualify for the 40% ND income tax credit for gifts to qualified ND endowment funds. (Note: you must donate the commodity first to get these tax advantages, not sell it and donate the proceeds later.)
- Appreciated investment assets, valued on the date of transfer, are tax deductible and you can avoid paying capital gains tax. These gifts may also qualify for the ND income tax credit.
- Charitable IRA rollover counts as your required minimum distribution, but you don't need to claim the donated portion as federal income and the gift may qualify for the 40% ND income tax credit.
- Gifts of mineral acres outright, assignment of mineral royalty income, or make the Larimore Community Endowment Fund an income or remainder beneficiary of your family mineral trust.
