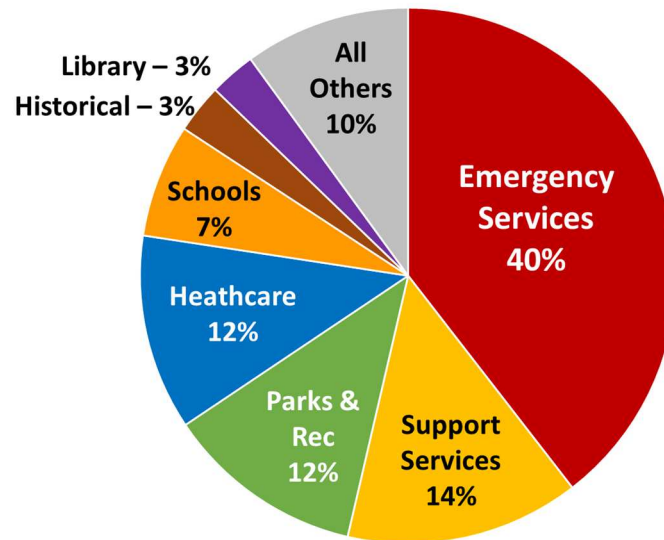
We encourage each family, individual, and business to make some sort of gift from time to time. Over the years, all those gifts will grow this permanent fund to be an even more valuable resource for our communities.

Our Service

Since 2017 yearly grants have been awarded in our area, totaling over \$29,000. Unfortunately, grant requests greatly outweigh the money available and our committee is usually only able to fund (or partially fund) about 15% of the requests.

Funded (or partially funded) projects include:

- Splash Path at Rotary Park
- Replacement Boots for the Scranton Fire Protection District
- Pediatric Crash Cart for Southwest Healthcare Services
- The Giving Tree
- Support for the Amidon Community Cupboard
