Grenora's Centennial

Your Foundation was Host

They came with great anticipation—and were not disappointed. Alumni, teachers, past residents and many others poured into town the weekend of July 1-3 to celebrate Grenora's 100th birthday. With a rainy summer Grenora was abundantly green, and the town was spiffed up to properly greet them all. Throughout town, conversation flowed, laughs were ample, memories revived. Grenora's Centennial celebrated that the town and its school have not only survived — they have *thrived* !

The new addition to the school served as registration site for all new arrivals and the Grenora Public School Foundation was there in full force, with additional volunteers, to greet, serve refreshments, and give tours of the impressive facility.

Registrants gathered at the new gym to reacquaint with old classmates and friends, view class pictures, and then gather in small groups to tour the new second gym, weight room, 7 classrooms, teacher lounge, locker rooms and bathrooms. As they walked the air conditioned facility, they learned that the 1968 structure (except the gym) would also be air conditioned when all work was completed by the start of the school year. Except for that 1968 gym, which was used for the Centennial's hypnotist show, the older structure was off limits to the public, as it was receiving extensive updates to all windows and entry doors, administration offices, restrooms, and kitchen, addition of a video conferencing room, and a larger library. The \$9.95 million project yielded far more than the new addition; the 1968 structure has been vastly improved to better educate the district's children. While small towns in the region have closed their schools, Grenora proudly welcomes this impressive structure to support a promising future. School board member Rick Foss (GHS '81) and Principal Joe Paine joined Foundation Advisory Cmte members to give tours of the facility. Did we think to take a picture of all the informative, distinguished tour guides? Nope. We were too busy enjoying the tours with our fellow partiers.



“On this Site” plaques such as this one at the new school addition were posted throughout town during Grenora’s Centennial as a self-guided walking tour to tell the 100 year story of businesses and organizations which are part of the area’s rich history. A website now holds these plaques and invites others to contribute more pictures, facts, and memories so that they may be posted to that website. Go to the City of Grenora’s website www.grenora.org and click on **“A HISTORY WEBSITE.”** Some fun facts which appeared on the school’s plaque, and now on that website include:

- Grenora School District 94 formed in 1918 with a one room structure on the same general site.
- The 1919 school cost \$39,000. It was demolished in 1969. Its original gym had a “disappearing” stage
- A larger gym was added to the north side of the 1919 school in 1939 and demolished in 2014.
- With the early 1960’s closings of Hanks, Zahl and several rural schools, District 99 built a new elementary and high school in 1968, costing just under \$700,000.
- A new addition on the site of the 1919 structure was added in 2016.



Many Ways to Support the Grenora Public School Foundation

In addition to simply writing a check to the Grenora Public School Foundation or clicking on “DONATE” at our website www.grenorakids.net, there are many other tax-deductible options to support our school system:

Life Insurance/Retirement Accounts

An easy process which has no impact on your current financial situation.

Gift of Stock

Lets you take a tax deduction for the current market value of the stock and avoid capital gains tax.

Bequest

A promise to give property or money after you die, which potentially saves substantial estate tax.

Charitable Gift Annuities

The donor transfers property to the NDCF/Grenora Public School Foundation and NDCF pays a given amount at each selected payment period to annuitant(s) (usually donor and spouse), a portion of which is tax free. The annuity amount is fixed and will not change with current investment or market conditions, which is especially attractive if you have a stock, CD or other investment that is not producing a large amount of income.

Charitable Remainder Unitrust

A special trust that pays income to family members. After the income payments have been completed the remainder is distributed to NDCF for the Grenora Public School Foundation. This bypasses the capital gains tax, provides increased income, and takes a tax deduction for the donation.

Funding Parameters

Establish guidelines to help the Foundation consistently consider and promote those activities which best represent the intent of donors' generous contributions and which support the vision of the school's board of directors. Work continues on these guidelines which will be available by website and by other means for public review.

The Grenora Public School Foundation is an organization independent of the Grenora Public School which collaborates with the School's Board of Directors to assure Foundation goals and actions support the policies and goals of Grenora Public School and properly consider Foundation donor wishes.
