**GUPPIES** (Glen Ullin People Promoting Interest & Events) was established in 2004 and does a variety of community projects, including flower planters in front of businesses.



#### Fund Growth Over the Years

The Glen Ullin Community Foundation ended the third quarter of 2021 with a market value of over \$198,000! This is a permanent fund so that money will provide grant dollars forever.

How did we get to this amount? First, Ishmael Diede left a gift in his will for this area. Other donations from residents and businesses, including a substantial gift of almost \$20,000 from the Glen Ullin Lions Club, has aided our growth. The money has been invested on our behalf and has grown over the last decade, by about \$42,000! And during this time we've ALSO awarded over \$50,000 in grants from the fund!

The chart below shows the **fund balance on December 31 of every year** since it started.



Richardton has been able to grow THEIR community foundation to over \$450,000. How? By various community organizations, businesses, and individuals making donations on a regular basis over time. All those gifts together help the fund grow so that it can give back even more to the community every year.

#### Generous Tax Credit Provides Big Incentive To Give

The North Dakota Charitable Income Tax Credit allows individuals that donate \$5,000 or more and businesses that donate any amount to qualified endowment funds to receive up to a 40% state tax credit.



The Glen Ullin Community Foundation is managed as a "qualified endowment fund" so donations may qualify for the tax credit if they meet the above criteria.

Depending on your tax bracket, this means a \$5,000 gift to the Foundation may end up only costing about \$2,000 after taking advantage of the tax credit and other deductions!
