# **\$8,710 Awarded in 2024**

The Enderlin Area Community Endowment Fund awarded the following grants in April of this year:

- \$3,571 to the Enderlin Lions Club for funding for the Ransom County Sheriff's K-9
- \$4,071 to Happy Trails Childcare for their kitchen remodel project
- \$1,068 to the Village Family Service Center for school-based mental health therapeutic supplies

Grants are awarded once a year. 501(c)(3) status organization with а government agency may apply. Applications are available online at www.NDCF.net/Enderlin.

United Prairie Foundation, based out of Sheldon, ND, is a nonprofit dedicated to restoring native prairie habitats. Their mission is to make real prairie common again by planting a diverse mix of wild prairie plants that are native to the area. Another part of the foundation is the Leafy Spurge Beetle Program. The program was created to help fight Leafy Spurge, an invasive plant that infests local pasture and grasslands.

A grant from the Enderlin Area Community Endowment Fund in 2023 helped pay for a trip to Medora, where 4-H students collected beetles


to battle leafy spurge.
